1. **Sign-up** online at www.CourtsNoMore.com
2. **Watch** these Two Video Series:
1st Victim Videos - Education and Safety (watch this first)
2nd Domestic Violence (Login for this one)
3. **Pass Part One:** the Online written exam, then
4. **Successfully Complete Part Two:** this Oral Exam is by telephone: (Toll Free: 877-484-0868 Tues, Thurs, Sat 7am - 7pm)
5. **Print** your *Certificate of Completion* and submit it

This Program is Easy to Complete Because It's

- * **No Meetings** to Attend
- * View at Your **Own Pace**
- * **View Multiple Times**
- * Use most **Any Computer**
- * **Short** Duration

TIPS

1. Videos may **pause** from time to time due to the number of people on your local area access, firewalls, the power / speed of your computer, etc. **Dial-up connections do not work.**
2. You can use **Low** or **High** Resolution. Determine which resolution works best on the computer you are using.
3. When Using **Library** or **Public Access** computers make sure you have use of earphones.
4. ➔ **68% fail** the written test the first time.
If you view the videos just to get through them quickly, then you probably will not be prepared to pass Part Two, the Oral Exam.

Take your time and learn what is being said in the videos.

Attention !!

Important ➔ YOU MUST TAKE BOTH PARTS OF THE EXAM WITHOUT HELP FROM ANYONE and that includes your spouse, girl/boy friend – anyone. No one is to take the tests for you.

Contempt of Court - If someone takes the tests for you, then YOU may be held in contempt of court; be fined, jailed or both.

To Get Started – Follow These Steps

1. You *must have* an email address.
2. Have your **Docket #** available.
3. Pay **\$87** by Credit Card or by **U.S. Postal** Money Order

A. If using a **Credit Card**, then continue to Step 4...

4. Go to: **www.CourtsNoMore.com**
5. Go to the **Offenders** section, and
6. Click where it says to **purchase** the program, this will lead you to the “**Please Login**” page.

See where it says **Not Registered Yet ?** Click → **Signup here**

7. To use a credit card, Click the **CourtsNoMore Video Tutorial (\$87)** and continue to complete the information for the fill-in boxes.

8. Go through the payment process for Credit Cards by clicking:

2CO Checkout

9. After successful payment you will receive an instant email message with your **password**. With your Password, use your **Case #** or **Docket #** to begin the CourtsNoMore Tutorial Program.

B. If paying with a **Money Order**, follow these instructions:

CourtsNoMore accepts **only** a
United State Postal Service Money Order.

- A. Obtain the Money Order **only** from the Post Office and make it payable to **CourtsNoMore** for \$87.

- C. Allow **7** days from the date of mailing for your password to be sent to **your email address** so you can begin the Tutorial Program.

What to Do and What to Expect

- (1) **Set up** your account at *CourtsNoMore.com*

When you receive your password by email have your Docket # available.

Go to the **Offenders** page and under “**Follow These Steps**” click **set up** and complete the information. Then **Login**

- (2) **Learn All Videos** in **Both** Series.

1st **Victim Videos - Education and Safety** (watch this one first)

2nd **Domestic Violence**

You can view the sessions as many times as you wish during the time period set by the court.

- (3) **Pass** Part One: **Online Written Test** (Passing grade is 80.)

You can take the written test *as many times as needed to pass*, but you have to complete both parts of the exam within the time limit.

When you pass Part One print the instructions how to take Part Two. A link to these instructions can be found on the main **Offender** page where all the Domestic Violence Videos are.

- (4) **Successfully Complete** Part Two: **Oral Exam**

Call: **877-484-8068** **Tues, Thurs, or Sat** **7am - 7pm**

Find a quiet place to make the call.

The questions on this oral exam are to confirm you learned the concepts taught in the videos. After 5pm on the day after you take the Oral Exam, visit the **Offender** page; if you passed then it will say so above the Domestic Violence Videos.

Note: The **\$87** fee includes two attempts at passing Part Two. Additional attempts are **\$22** each, prepaid.

- (5) **Certificate of Completion** Upon successful completion of Part Two, your *Certificate of Completion* can be printed. Go to the **Offender** page where all the Domestic Violence Videos are and Click here to view your certificate.
