

TIPS

1. Videos may **pause** from time to time due to the number of people on your local area access, firewalls, the power / speed of your computer, etc. **Dial-up connections do not work.**
2. You can use **Low** or **High** Resolution. Determine which resolution works best on the computer you are using.
3. When Using **Library** or **Public Access** computers make sure you have use of earphones.

What to Do and What to Expect

- (1) **Login:** When You Receive Your Password by email, have your Case # or Docket # available.
- (2) Watch **All Videos** in **Both** Series.
You can view the sessions as many times as you wish during the time period set by the court or prosecutor.
- (3) **Test:**
You can take the test as many times as needed to pass, but you have to pass it within the time limit. This test is not tricky or difficult, but you must watch all the videos to pass.
